The Salsa Challenge is located at 100 N. Seville.

Set-up on Saturday from 3:00 until 4:00 p.m. or day of event at 7:00 a.m. (Must be completely set-up by 9 a.m.) Those arriving after 9:00 will not be allowed to participate and there are no refunds. Prior to your arrival, placement of the space will be arranged and your name will be placed on your table so you will easily be able to locate it. The Chamber will provide you with a 6-foot table, plastic table cloth, chips, tasting cups & trays, judges cup, napkins, plastic gloves and ticket hole punch

Individual Application Fee is \$25.00 – Restaurant Application Fee is \$35.00

Teams are required to make a minimum of three gallons of Salsa. Salsa must be stored in sealed containers in covered ice chests.

Contestants are required to supply their own canopy, chairs, ice chest, ladle or serving utensil, serving bowl, water, bucket, paper towels, liquid soap, plastic wrap and sign.

We (I, applicant and the business I represent), hereby enter the San Clemente Salsa Challenge at our own risk and will abide by all rules and regulations of the San Clemente Salsa Challenge, San Clemente Fiesta and San Clemente Chamber of Commerce. We understand we have, no larger than, a 10x10 space.
